



RULES AND REGULATIONS

For your planning and protection, please read these carefully. In addition, plan to share this information with your exhibitor personnel.

A. THE FOLLOWING PRACTICES ARE EXPRESSLY PROHIBITED:

Use of video – media recording equipment without permission from show management

Subletting of virtual space to another business, firm, or organization; parent or subsidiary companies accepted

Removal of exhibitor landing pages prior to the exhibition's close

Any behavior deemed inappropriate or detrimental to NAALT, WALT, PBM 2021 or other exhibitors

Products/services that will be displayed must be listed on the application. Products and/or services not listed on the application may not be exhibited without prior approval from show management.

NAALT - WALT reserves the absolute right to determine the appropriateness of products or services to be exhibited at its meetings and may decline at its sole authority to allow exhibitors to participate in PMB2021 exhibits.

Products must meet the regulatory requirements in the countries in which they are sold i.e. FDA, CE, etc.

NAALT - WALT reserve the right to remove exhibitors and their accompanying exhibit material from the show floor in the event that an activity or presentation of product is deemed, in their sole discretion, inappropriate or detrimental to the professional nature of the exhibition.

Exhibitors and their representatives shall at all times conduct themselves in a professional manner and shall not disparage or libel fellow exhibiting companies, member companies, NAALT, WALT, PBM 2021 Affiliates or the employees or representatives of the aforementioned organizations, or engage in other activities detrimental to the event.

If exhibitors do engage in any prohibited conduct, NAALT reserves the right to cancel the exhibitor's space without further notice and without obligation to refund monies previously paid and to re-sell exhibit space assigned.

B. INDEMINIFICATION

The exhibitor agrees to indemnify and hold harmless NAALT, WALT and their Affiliate sponsors including the officers, directors, employees, members, and agents of each, from any and all damages, liability, expense (including attorneys fees) out of; (i) the occupancy of virtual space by the exhibitor, or the exhibitor's agents or servants, (ii) any fault or negligence by the exhibitor and/or, (iii) any failure on the exhibitor's part to comply with any of the covenants, terms and conditions, herein contained, or otherwise, in each case whether or not such damages, liability, and expense, are caused by or due to the failure of NAALT, WALT and their Affiliate sponsors or any of their members including the executive staff and Board to perform any of the covenants herein, expressed or implied. Upon signing the application, the exhibitor expressly releases the foregoing institutions, individuals, and committees from any and all claims for loss, damage, or injury.

Certifying bodies will be prohibited from exhibiting unless an educational partnership with NAALT has been established. NAALT reserves the right to make adjustments in booth assignments deemed necessary. NAALT reserves the right to reject any applications for space, in NAALT's sole discretion (with or without cause).

E. CANCELLATION AND TERMINATION

NAALT may cancel any accepted application and terminate an assignment of space (i) for cause, at any time, or (ii) without cause not less than 60 days prior to commencement of NAALT's Annual Meeting.
